

THE COURT: ALL RIGHT. I DON'T KNOW WHAT THE COURT 1 EXHIBIT NUMBER WOULD BE AT THIS TIME. 2 THE CLERK: I THINK IT IS NUMBER 20. 3 THE COURT: 20? VERY GOOD. 4 MR. BARENS: YOUR HONOR, FOR THE RECORD, I WOULD LIKE 5 TO COMMENT, SIR. 6 7 THE COURT: YES? MR. BARENS: ALL OF THE DOCUMENTS REFERENCED BY THE 8 PEOPLE IN THE NOW-TO-BE-MADE COURT EXHIBIT, WERE RELINQUISHED 9 10 BY MY OFFICE TO MR. HUNT'S COUNSEL RIGHT AFTER THE PRELIMINARY HEARING. SO I HAVE NEVER HAD THESE DOCUMENTS 11 EXCEPT FOR PURPOSES OF THAT PRELIMINARY HEARING. SECONDARILY, 12 IN THE DISCOVERY THAT WOULD BE POST-PRELIMINARY HEARING 13 WHICH I UNDERSTAND IS APPROXIMATELY TWO-THIRDS OF THE GROSS 14 DISCOVERY AVAILABLE NOW IN THIS MATTER, HAS NEVER BEEN 15 16 SUBMITTED TO DEFENSE COUNSEL IN LOS ANGELES. 17 THE OTHER POINT WE HAVE, I DID RECEIVE FROM MR. WAPNER'S OFFICE, WHICH MR. CHIER IS EXHIBITING TO THE 18 19 COURT RIGHT NOW, THIS DISCOVERY FRIDAY NIGHT THAT APPLIES 20 OR PERTAINS TO I BELIEVE, THE LOS ANGELES MATTER. 21 I OBVIOUSLY HAVE NOT HAD AN OPPORTUNITY TO REVIEW 22 THAT TWO OR THREE INCHES OF MATERIAL EXCEPT IN THE MOST 23 CURSORY MANNER. 24 MR. WAPNER WAS COURTEOUS ENOUGH TO GIVE US AN 25 INDEX AND I LOOKED AT ONLY TWO OR THREE OF THE DECLARATIONS 26 IN THERE TO DATE. 27 BUT OBVIOUSLY, WE HAVE PREPARATION PROBLEMS IN

MR. CHIER: YOUR HONOR --

THE COURT: YES?

MR. CHIER: THIS DISCOVERY TURNED OVER BY MR. WAPNER
FRIDAY NIGHT PURPORTS TO BE THE PENALTY PHASE DISCOVERY. AND
THIS IS THE FIRST TIME MR. WAPNER HAS TURNED OVER ANY DISCOVERY
OR HAS SPECIFIED WHAT IT WAS SPECIFICALLY THAT HE INTENDED
TO RELY UPON.

I WOULD LIKE TO REMIND THE COURT THAT IN THE SAN MATEO COUNTY CASE, THE PRELIMINARY -- THE ORIGINAL DISCOVERY PRIOR TO THE PRELIMINARY HEARING CONSISTED OF SOME 12,000 PAGES, YOUR HONOR WHICH IS IMPOSSIBLE TO ASSIMILATE AND GO THROUGH WITHOUT KNOWING SPECIFICALLY WHAT IT IS THAT THE PEOPLE INTEND TO RELY UPON CONTAINED THEREIN.

THIS IS FINALLY, AT THE -- AFTER THE PENALTY PHASE
IS HALF OVER, THE DISCOVERY WHICH I WOULD ESTIMATE IS AT
LEAST THREE INCHES TALL, YOUR HONOR. I WOULD ASK THE COURT
TO TAKE SOME JUDICIAL NOTICE OF THE FACT THAT IT IS
APPROXIMATELY THREE INCHES IN HEIGHT.

MR. WAPNER: YOUR HONOR, MAY I FILE WITH THE COURT,
A LETTER THAT I SENT TO MR. BARENS AS WELL AS A LIST OF
ATTACHMENTS THAT I SENT ALONG WITH THE LETTER.

AND ESSENTIALLY WHAT THE LETTER SAYS IS THAT I

AM SENDING THIS NOW ONLY BECAUSE YOU ARE CLAIMING THAT YOU

DIDN'T HAVE IT AND IT IS ALL PART OF THE ITEMS, ALMOST ALL

OF WHICH ARE INCLUDED IN THE LIST I WOULD ASK TO HAVE MARKED

AS A COURT EXHIBIT AND --

THE COURT: PREVIOUSLY SUBMITTED TO HIM, YOU MEAN?

MR. WAPNER: RIGHT. IN OTHER WORDS, WHAT I GAVE THEM

FRIDAY WAS JUST COPIES OF WHAT I BELIEVE THEY PREVIOUSLY HAD. 1 THAT IS WHAT I SAID IN THE LETTER. 2 SO IF THE LETTER AND ATTACHMENT CAN BE MARKED 3 AS THE NEXT COURT EXHIBIT, I WOULD APPRECIATE IT. 4 THE COURT: THAT WILL BE 21. 5 MR. BARENS: YOUR HONOR, AGAIN, I HOPE THE COURT DOES 6 NOT PLACE TOO MUCH EMPHASIS ON THE FACT THAT BY SAYING WELL, 7 IT WAS PREVIOUSLY SUBMITTED TO THEM, SOMETHING THAT WE HAD 8 A YEAR AND A HALF AGO --9 THE COURT: WHY DON'T YOU LOOK IT OVER AND SEE WHETHER 10 YOU HAVE GOTTEN IT BEFORE? YOU CAN TELL ME WHAT PART OF IT 11 YOU NEVER SAW. 12 MR. BARENS: I AM ATTEMPTING TO DO IT. I MENTIONED 13 TO MR.
